  - iti. As per the proviso to section 2(15) of the Income Tax Act, 1961 w.e.f. 01-04-2009, "The advancement of any other object of general public utility shall not be a charitable purpose, if it involves the carrying on of any activity in the

ce in relation to any trade, commerce or business, for a cess or fee or

- any other consideration, irrespective of the nature of use or application, or retention, of the income from such activity".
- iv. Exemption u/s 80G granted will be withdrawn in case violation of any of the provisions of the Income Tax Act, 1961 is noticed.
