II. Status Report of Nityaasha (Post Relocation to Gyan Adab)

- Nityaasha Foundation office premises relocated and started functioning at Gyan Adab, Kalyani Nagar from 20th February 2018.
- Divyaasha Project to close down from 1st April 2018. Email dated 08.02.2018 sent to Dr. Deepa Divekar by Mr. Farook Marchant, Founder & Trustee informing about the same. All enrolled children were informed and counseled regarding the closure of the Divyaasha Project.
- 2-Staff members (Medical Social Worker & Pharmacist) appointed to operate Nityaasha centre. Administration & Accounts to be managed by Messung Staff.
- Nityaasha centre to operate twice in a week (Tuesday & Thursday) to dispense medical aid (3 strip per day per child) excluding insulin we have surrendered our drug license. A tie-up with Medplus, Kalyani Nagar, Pune is made to dispense Insulin.

- Nityaasha Beneficiaries to visit the center with latest doctor's prescription to collect the medical aid. Free counseling services to be provided at the center along with home visit for genuine families. Social Worker & Pharmacist to maintain all records pertaining to medical aid dispensing and center visits.
- The current budget for the period of one year (2018-2019) of 2500000/- allotted for the existing 111 Type 1 Diabetes Children under the Madhurasha Project. These children are from KEM Hospital (98 children), Dr. Arundhati Khare (11 children), Dr. Varsha Jagtap (1 child) & DY Patil Hospital (1child).
- No new T1DM enrollment for this year.
- Annual Pathology Test & Half yearly HbA1c test to continue only through sponsorship.
- To inform all the associated doctors regarding scaling down of activities at Nityaasha.

III. **HIGHLIGHT ACTIVITIES:**

- **Half yearly pathology test (Red Category - HbA1c above 10%):**
110 children completed half yearly HbA1c test in June & July 2018. 35 children are in Red category. Interactive session with Dr. Smita Dhadge, KEM Hospital was organised at Nityaasha Centre on 26.07.2018. 22 children along with their parents participated on the session.
- One Nityaasha Managing Committee Meeting was held at Gyan Adab centre, Kalyani Nagar on 18.03.2019.
- Nityaasha received FCRA Registration No. 083930728 on 1st March 2019.
